Remarks By The President



Tn November 2021, the "Historical Resolutions" passed at the Sixth Plenary Session of the 19th Central Committee of CPC pointed out that "the world has entered a period of turbulence and changes", and we "face complex and severe international situation and unprecedented external risks and challenges". During the past year, the spread of covid-19 pneumonia was weakening worldwide, but there were repeated outbreaks, and the epidemic is still affecting the world's politics and economy seriously. The world shows a clear trend of chaos, division and more unpredictable factors.

In the new global strategic environment, IISS, PKU aligned itself with the right direction and made gratifying progress in its academic as well as strategic and

policy researches. IISS has taken on projects collectively or individually, including major projects of the National Social Science Fund (NSSF), projects entrusted by Ministries, projects entrusted and funded by China-United States Exchange Foundation (CUSEF), interdisciplinary research projects supported by PKU and internal research projects supported by IISS; some have been successfully completed and won recognition and praise of relevant departments, while others are in progress. In November 2021, the 8th annual "North Pavilion Dialogue" was held through video conference as before. As in previous years, participants at home and abroad took active part in the dialogue, held in-depth discussions of the global strategic situation, and put forward pertinent suggestions on policies and cooperation plans to address challenges in various countries and regions. The "North Pavilion Seminar" has been held eight times this year. The International and Strategic Studies Report, Think Tank Frontier and Think Tank Digest were published in 15, 12 and 12 issues respectively this year.

In 2021, IISS launched a new platform for exchange of ideas - "Beige Salon", where excellent Chinese young and midcareer scholars specializing in international issues are brought together to exchange views, activate ideas, expand cooperation and make common progress, for the purpose of achieving the effect of "small core, big influence". Through this platform, we also hope to break the "small circle of people" in diplomatic and international relations research, and promote more effective policy interaction, multidisciplinary cross-cutting studies and communication between scholars and entrepreneurs. Academic activities under Beige Salon were held five times this year.

Since China International Strategic Review (CISR) in Chinese and English versions were expanded into semiannual editions in 2018, the quality has been steadily improved and it gradually exerted a greater influence. Due to insurmountable objective obstacles, the publishing of the Chinese version of CISR was delayed. We apologize to our readers. Fortunately, thanks to the support of the World Affairs Press Co., Ltd. and other agencies, we have achieved new progress in the publishing and distribution of the journal.

We would like to take the opportunity of publishing this annual report to thank the institutions and individuals who have always guided and supported our work, including the leaders and various departments of PKU, government departments such as the Ministry of Education and the Ministry of Foreign Affairs, entrepreneurs, academic colleagues and young students inside and outside the university, as well as all directors of IISS. In particular, we would like to express our gratitude to Dai Bingguo, Former State Councilor, PRC and Honorary President of IISS, for his constant guidance and concern for us. The China-United States Exchange Foundation, under the leadership of Mr. Tung Chee-hwa, Vice Chairman of the Chinese People's Political Consultative Conference (CPPCC), has been supporting the Institute's research and foreign exchange work for many years, for which we are very grateful. We are determined to work harder and be better prepared for the new glorious and arduous tasks of 2022.

About IISS, PKU

Officially founded in October 2013, the Institute of International and Strategic Studies (IISS), Peking University (PKU) was formerly the Center of International and Strategic Studies of Peking University, established in May 2007. Former State Councilor Dai Bingguo was invited by PKU to serve as honorary president of IISS. IISS is an entity affiliated with the School of International Studies, PKU, and directly uses Peking University in its name. Its council members include senior scholars and experts inside and outside PKU.

IISS aims to promote the development of academic and policy research on world politics, international security, global strategy, and related topics. It focuses on the analysis of international situations that China faces as well as the international strategies of related countries. Based on such analysis, IISS publishes and presents research results, highlighting policy significance and insights to relevant authorities. IISS is committed to providing intellectual support for China's decision-making in the area of international strategy and offers education in relevant subjects. It also guides the public in understanding issues related to national security and international strategy in a sound, accurate, and reasonable way. Its research products include the occasionally published International and Strategic Studies Report, Think Tank Digest, and Think Tank Frontier; the semiannual China International Strategy Review (English and Chinese) and International Strategy Research Series of Peking University; and research reports trusted by government agencies, enterprises and public institutions, as well as internal reports and student research projects.

Following the trend of globalization, IISS has witnessed an array of interwoven and interacting issues of politics, economy, military, science, technology, culture, religion and society around the world. Non-traditional security issues, such as ecological environment, public health, and natural disasters, are becoming subjects of international strategy research. IISS encourages carrying out international strategy research from multiple and interdisciplinary perspectives and strives to achieve innovation in theory and methodology while focusing on practical issues. IISS values the practice of field research at home and abroad in international strategic studies, and encourages the completion of research with practical views and policy implications based on field work.

IISS has successfully undertaken and accomplished many projects through the National Social Science Fund of China and Major Key Projects of Philosophy and Social Science for the Ministry of Education. It also provides targeted research and decision-making consultation services for the Foreign Affairs Office of the Communist Party, the Ministry of Foreign Affairs, the International Department of the Central Committee of the Communist Party of China, the National Defense University, and the Academy of Military Science of the Chinese People's Liberation Army. The Eighth Annual North Pavilion Dialogue


O n November 3-4, 2021, the Eighth Annual Meeting of "North Pavilion Dialogue" was held at Peking University (PKU). "North Pavilion Dialogue" was organized by the Institute of International and Strategic Studies (IISS), PKU with enormous support from the leadership of PKU, Office of International Relations, as well as the School of International Studies (SIS) of PKU. Both domestic and foreign former politicians and renowned experts with extensive political experience, profound academic accomplishments and comprehensive strategic visions are invited annually to the "North Pavilion Dialogue" at the PKU to explore the international situation and the prospects of world politics.

This year, "North Pavilion Dialogue", titled "Global Trends and Policy Recommendations 2021 in the Wake of the COVID-19 Crisis", was held as a video conference, aiming to explore the impact of the COVID-19 pandemic, the changing geostrategic landscape in Asia-Pacific amid China-U.S. tensions, climate change and environmental issues, and the changing geostrategic landscape in Eurasia.

Participants agreed that COVID-19 has brought new turbulence and risks to the world economy and politics. All countries must work together to cope with the pandemic and restore the economy more effectively. At present, Sino-U.S. relations are facing difficulties, but there will not be a "new cold war". There are important common interests and cooperation opportunities between the two countries. In the face of increasingly urgent climate crisis, international cooperation has made new progress, but still faces domestic political and geopolitical obstacles. It is urgent for countries to take more practical actions to effectively promote multilateral coordination. Participants put forward many useful suggestions on how to calmly and pragmatically deal with the above mentioned challenges.

A total of 13 international guests were invited to this annual meeting: Mr. Kevin Rudd, former Prime Minister of Australia and president of the Asia Society; Mr. John Negroponte, former deputy secretary of State of the United States; Mr. Joseph Nye, Jr., former assistant secretary of Defense of the United States, former chair of the National Intelligence Council of the United States and distinguished service professor emeritus of Harvard University; Mr. Shivshankar Menon, former National Security Advisor to the Prime Minister of India; Ms. Yoriko Kawaguchi, former Minister of Foreign Affairs of Japan; Mr. Kim Sung-Hwan, former Minister of Foreign Affairs and Trade of the Republic of Korea; Mr. George Yeo, former Minister of Foreign Affairs of Singapore; Mr. Marty Natalegawa, former Minister of Foreign Affairs of Indonesia; Mr. Nabil Fahmy, former Minister of Foreign Affairs of Egypt; Mr. Andrey Kortunov, director general of the Russian International Affairs Council; Mr. David Miliband, former Foreign Secretary of the United Kingdom; Mr. Thierry de Montbrial, President of French Institute of International Relations (IFRI); Mr. Volker Perthes, UN secretary-general special representative for Sudan and former Director of Stiftung Wissenschaft und Politik (SWP).

The "North Pavilion" as in the name "North Pavilion Dialogue", formerly known as the Luella Miner Pavilion, is situated in the central part of the picturesque Yan Yuan campus and now accommodates the office of the IISS.



ISS, PKU held the "Symposium on China International Strategic Research under the New Situation" and the First Beige Salon on April 23, 2021. The participating guests had profound discussions on topics such as the changes in China's international strategic environment, the existing shortcomings of China's international strategic research and approaches for improvement, and how to run "Beige Salon" successfully.

On May 27, 2021, IISS, PKU held the symposium on "Indo-Pacific Strategy under the Biden Administration: Progress, Prospects and Responses" and the Second Beige Salon. The experts exchanged views on topics such as the overall conception and policy orientation of "Indo-Pacific Strategy" under the Biden Administration, the interaction around "Indo-Pacific Strategy" among U.S., Japan and EU, the economic agenda and military deterrence under "Indo-Pacific Strategy" framework.

On September 22, 2021, IISS, PKU held the workshop entitled "Sino-U.S. Competition from the Perspective of International Development Theory and Policy" and the Third Beige Salon. Experts at the workshop exchanged views on topics such as policy of China's aid for foreign countries and its international development cooperation, Sino-U.S. competition in the fields of developmental finance, digital trade, climate change and infrastructure construction, as well as the interactions of the two countries in the development of regions such as Southeast Asia, South Asia, Central Asia and Europe.

On October 28, 2021, IISS, PKU held an online symposium on "National Security and Competition-Cooperation Games in the Context of Scientific and Technological Changes" and the Fourth Beige Salon. From the perspective of the "Construction of National Security Discipline", the participants exchanged ideas on topics such as the influence and action mechanism of scientific and technological changes on national security and international stability, the possible impact on the field of traditional security, the current cutting-edge trends in the fields of non-traditional security such as biology, digital sphere, industry and network, as well as ideas and methods for the development of national security under the new circumstances.

Oⁿ November 24, 2021, IISS, PKU held an online symposium on "EU Strategic Autonomy: Background, Progress and Response" and the Fifth "Beige Salon". Focusing on "EU Strategic Autonomy", the participating experts deeply analyzed its background and internal and external motivations, and emphatically discussed the specific progress and possible limits of "EU Strategic Autonomy".

On February 22, 2021, Prof. Wang Jisi and Prof. Yuan Ming attended the 19th Lanting Forum and gave speeches on the topic of the forum "Dialogue and Cooperation, Managing Differences—Geting Sino-U.S. Relations Back on Track". Prof. Wang Jisi stated that at present, China and the United States should seize the opportunity to restart the exchange mechanism and understand each other's thinking mode. Prof. Yuan Ming claimed that the collective cognition of the world and future is emerging at the rage of COVID-19.



A t the invitation of the School of Politics and International Relations of Lanzhou University, Associate Prof. Guan Guihai, attended the academic seminar of the "20th Anniversary of the Founding of the Shanghai Cooperation Organization (SCO): Retrospect and Prospect" in Lanzhou on April 10, 2021, and delivered a keynote speech entitled "Russia and Central Asia's Perceptions of the SCO".

On April 13, 2021, Prof. Wang Jisi was invited to participate in the dialogue program of China-U.S. Focus, where he and David Lampton, Emeritus Professor of Johns Hopkins University in the United States, were interviewed by James Chau, and exchanged ideas and debated on the important factors in Sino-U.S. relations, "Pacific Community" and other topics.

On April 22, 2021, Yang Dianyao, Vice President of Huawei's Strategic Procurement Department, Zhong Nan, Senior Strategy Manager and Senior Director for Industrial Development of the Strategy Department-Standards and Industrial Development Department, Wang Nannan, Senior Manager of the Strategic Procurement Department and their colleagues visited IISS, PKU. IISS President Wang Jisi, Vice President Yu Tiejun, Vice President Gui Yongtao and Senior Research Fellow Lei Shaohua attended the meeting. The two sides had discussions and exchanges on topics such as the world configuration, international supply chain, Sino-U.S. relations, and Sino-Japanese relations.

On May 4, 2021, Prof. Wang Jisi, hosted a public video seminar organized by the Doha Forum with the topic of "Filling the Vacuum: The Future of Chinese Foreign Policy and Global Ambitions". Participating experts delivered keynote speeches and had exchanges on topics such as China's status in the world order, changes in Sino-U.S. relations, and China's diplomatic ambitions.







From May 24 to 26, 2021, Associate Prof. Guan Guihai and Senior Research fellow Zhao Minghao attended the 2021 Annual conference of the Council of Councils hosted by the Council on Foreign Relations on behalf of IISS, PKU. They discussed the following six major topics: "The Biden administration and the future of multilateralism", "Addressing the challenges of nuclear proliferation", "Coordination of a new power", "COVID-19 vaccines and international cooperation", and "The state of global governance in the age of COVID-19".

From June 2-3, 2021, Associate Prof. Guan Guihai, was invited to attend the Shanghai Cooperation Organization (SCO) Forum on People-to-People Friendship in Wuhan and delivered a speech entitled "Cognitive Basis for Smooth Development of SCO" on the think tank sub-forum.



On June 11-13, 2021, Associate Prof. Guan Guihai, attended the "Seminar on Xi Jinping's Thought on Diplomacy and Overseas United Front Work" and delivered a speech entitled "Russia's Policy Towards Compatriots Abroad: Experience and Lessons".



On June 24-25, 2021, Associate Prof. Guan Guihai, attended the international academic seminar on the "20 Years of the Shanghai Cooperation Organization (SCO): Retrospective and Prospects" in Shanghai and delivered a speech entitled "Agreements Reached within the SCO: Consensus and Differences".

Exchange and Cooperation



In June, September and October, 2021, IISS, PKU and Korea Foundation co-organized a series of dialogue between scholars of of the two countries. Chinese and Korean scholars had warm discussions and exchanges on the issues of "The Multilateral Security Mechanism in Northeast Asia", "Competition and Cooperation in Science and Technology among China, Japan and South Korea" and "International Cooperation in Public Health".



On September 15, 2021, a delegation from IISS, PKU visited Huawei Beijing R&D Centre at the invitation of Huawei. They exchanged views with relevant experts on topics such as 5G technology and artificial intelligence. On October 16, 2021, the second symposium on "Russia under Pluralistic Perspectives" was successfully held online. The event was hosted by the Center for Russian and Central Asian Studies at Fudan University. Associate Prof. Guan Guihai, was invited to participate in this symposium. Guan Guihai presided over the session on Sino-Russian relations and gave a speech on "New Changes and Implications of Russian Sinology Research".
